In April 2014, U.S. Senator Richard Burr joined 10 colleagues on the Senate Select Committee on Intelligence (SSCI) in voting to release a report on the Committee's extensive investigation into treatment of detainees in the post-9/11 era.

Reliable sources expect that the report will include significant details about Aero Contractors, Ltd., a CIA-affiliated company based in Johnston County, North Carolina. There is already in flying kidnapped public record and reporting that Aero specialized in flying kidnapped men to torture chambers: foreign prisons and CIA "black sites" where they were held in secret and tortured.
